

Memorandum of Understanding between



Rambhai Barni Rajabhat University, Kingdom of Thailand and

Xinyu City Hongliang Training School of China, People's Republic of China

This memorandum of understanding is made at Rambhai Barni Rajabhat University located at 41 Moo 5 Thachang Subdistrict, Mueng District, Chanthaburi Province on 20 June 2023 between Rambhai Barni Rajabhat University by Assistant Professor Waigoon Tongaram holding the position of President of Rambhai Barni Rajabhat University, which hereafter in this memorandum will be referred to as "the University" and Xinyu City Hongliang Training School of China located at 10 Block C, Head Office Building, Wuxiang, Nanning, Guangxi, People's Republic of China by Mr. Guogiang Du holding the position of Chief Executive Officer of Xinyu City Hongliang Training School of China, which hereafter in this memorandum will be referred to as "the School".

1. Objectives

To strengthen a good relationship between the two parties and to extend cooperation on academic exchange, research and other areas, therefore both parties agree to create cooperation for mutual benefits.

2. Scope

The scope of cooperation includes any projects organized by each party according to demand and actionability in order to make this cooperation successful by co-determining specific details within the scope of authority determined by each party without breaking the related laws, ministerial regulations, rules, regulations and announcements. Any projects defined in this memorandum of understanding must depend on the agreement of both parties to promote and support the actions between the University and the School as follows:

- 2.1) Preparation of dual degree or joint degree or any other degrees
- 2.2) Exchange of students and education personnel
- 2.3) Development of students and education personnel
- 2.4) Exchange of knowledge and educational technology
- 2.5) Organization of other activities

3. Duration and Amendment of Memorandum of Understanding

This memorandum of understanding will be in effect for a period of 5 (five) years from the date of signing the memorandum of understanding. Amending, changing, adding, cutting



or cancelling any contents in this memorandum of understanding can be done by either party provided that written notice to the other party is made in advance not less than 30 (thirty) days and creating an amended memorandum attached to this memorandum of understanding.

4. Termination of Memorandum of Understanding

If either party wishes to terminate this memorandum of understanding, either party is required to notify the other party in writing in advance not less than 180 (one hundred eighty) days. If there are any projects in progress under this memorandum of understanding, such projects will be able to continue until completion within the period specified in the projects.

This memorandum of understanding is made in two duplicates with identical contents. Both parties have thoroughly read and understood the contents, therefore their signature and seal (if any) will be added before witnesses, and each party will keep one issue for each side. This memorandum of understanding shall come into effect from the date of joint signing.
